# RULES AND REGULATIONS FOR LAW STUDENTS CONFERENCE, 2023

#### **ARTICLE 1: Objective and Organization**

- I. The Prof. N. R. Madhava Menon Global Jural Conclave Law Students Conference, 2023 aims at promoting research, writing and cognitive skills among law students globally. It is also expected to facilitate a network amongst law students for mutual benefit and to encourage them to maintain brotherhood in the profession.
- II. The Law Students Conference (LSC) will be held on 16<sup>th</sup>-17<sup>th</sup> February, 2023 on the theme 'Dynamics of Liberty and Rights in Crisis'.

#### The sub themes are:

- 1. State, National Security and Individual Rights
- 2. Constitutionalism and Constitutional Crisis
- 3. Global Health Emergency and Rights
- 4. Individual Rights, Duty and Collective Good
- 5. Humanitarian Crisis and Human Rights
- 6. Disaster Management, Individual Liberty and State Responsibility
- 7. Right to Information and State of Emergency
- 8. Constitution, Emergency Response and Suspension of Liberties
- 9. Non-derogable Rights and State of Emergency
- 10. Climate Change and Individual Rights

## **ARTICLE 2: Participation**

#### I. From India:

Researchers from twenty-five teams that have qualified through Memorial selection process will participate in the LSC.

#### II. Other than India:

- i. Researchers from the teams as specified in Article 3.I of Rules and Regulations of Prof. N. R. Madhava Menon Global Jural Conclave 2023 Global Law Students' Conference Round will qualify for participation upon registration with the OC.
- ii. The participants can also register individually by mailing their interest to profine nonmooting@lloydlawcollege.edu.in. This is to enable the participants to form teams from different colleges and institutions.

#### **ARTICLE 3: Team Composition and Eligibility**

- I. The Law Students' Conference is open only for researchers of the MCC. However, during oral rounds of the MCC, no researchers will be permitted to be present in any of the court rooms. No deviation from this rule is permissible.
- II. The researcher from each participating team in the GJC to submit one original research paper individually and participate in the LSC.
- III. The research papers will be presented during the LSC by the respective researcher in each team.
- IV. The research papers selected by the committee of experts after peerreview will be published through international publisher in a collected volume by Lloyd Law College.

#### **ARTICLE 4: Abstract and Paper Submission:**

- I. All presenters shall submit their abstract to: lawstudentconference.ajc@lloydlawcollege.edu.in latest by 07<sup>th</sup> January, 2023.
- II. The soft copy of final paper shall be submitted by email to lawstudentconference.ajc@lloydlawcollege.edu.in latest by 29th January, 2023.

## **ARTICLE 5: Paper Presentation**

- I. The oral presentation of the research paper shall not exceed fifteen (15) minutes per presenter.
- II. Presenters exceeding the time limit will be liable to a penalty of two (2) marks per minute exceeded.

## **ARTICLE 6: Assessment of Research Paper**

- I. The research papers will be assessed by a Peer-Review Committee and every research paper will be marked out of total hundred (100) marks.
- II. The marking criteria and the marks allocated to each category are listed below:

4	Citation of sources	Maximum: 10 marks
5	Grammar, Language and Style	Maximum: 10 marks

#### **ARTICLE 7: Assessment of Paper Presentation**

- I. The paper presentation shall be assessed by a presentation committee and every presentation will be marked out of total hundred (100) marks.
- II. The marking criteria and the marks allocated to each category are listed below:

## **ARTICLE 8: Guidelines for Paper Submission**

- I. All research papers must be accompanied by an Abstract, not exceeding 200 words.
- II. The body of the manuscript shall be in Times New Roman, font size 12 and in 1.5 line spacing.
- III. The footnotes shall be in Times New Roman, font size 10 and in single line spacing.
- IV. Submissions must be made in the MS Word (.doc/docx) format and the citations must conform to the latest edition of the Bluebook.
- V. Co-authorship is impermissible. No deviation from this rule is allowed.
- $VI.\,The\,prescribed\,word\,limit\,is\,5,\!000\,words\,exclusive\,of\,footnotes.$

- VII. All queries, within prescribed time limit, shall be made only to: lawstudentconferenceajc@lloydlawcollege.edu.in
- VIII. All submissions, within prescribed time limit, shall be made via, e-mail to: lawstudentconference@lloydlawcollege.edu.in
- IX. The subject of the email shall be 'Submission for Global Students' Conference, 2023 (Title of the manuscript)'.
- X. The submission should be accompanied by a plagiarism report / similarity test report (one page only indicating the percentage of similarity).
- XI. The submission should be accompanied by a cover letter which must include the following details:
  - a. Name of author
  - b. Contact details- address and mobile number
  - c. Name and address of parent institution
  - d. Course currently being pursued/current year/semester
  - e. A declaration that the research paper is original and authored solely for the purpose of the Prof. N.R. Madhava Menon Global Jural Conclave (Law Students' Conference), 2023.
- XII. No indication shall be made in the research paper that may lead to identification of the institution / college of the participant or name of the participant. No presenter / researcher shall communicate his / her institutional affiliation or identity to anyone during the conference.
- XIII. The research paper must be written and presented in English Language.

#### **ARTICLE 9: Awards**

- I. The presenter scoring the highest marks in paper assessment and paper presentation cumulatively will be adjudged the Winner and shall be awarded the 'Prof. N.R. Madhava Menon Global Jural Conclave (Law Students' Conference), 2023 Best Presenter Award'.
- II. The presenter scoring the second highest marks in paper assessment and paper presentation cumulatively will be adjudged the 'Runner Up' and shall be awarded the 'Prof. N. R. Madhava Menon Global Jural

- Conclave (Law Students Conference), 2023 Best Presenter (Runner Up) Award'.
- III. All selected research papers will be published through an international publisher in a collected volume by Lloyd Law College.
- IV. All presenters will be awarded 'Certificate of Paper Presentation'.

# ANNEXURE - 1 DISOUALIFICATION AND PENALTIES

#### ARTICLE A1: Aim & Object

- I. The present Annexure on Disqualifications and Penalties forms an integral part of the Official Rules of the 'Prof. N. R. Madhava Menon Global Jural Conclave'-
- II. The aim of the Annexure on Disqualifications and Penalties is to ensure a fair and supportive contest in the 'Prof. N. R. Madhava Menon Global Jural Conclave' by providing means for ensuring compliance with the relevant provisions of the official rules.

#### ARTICLE A2: Unfair Means, Intimidation and Misconduct

- I. Cheating or use of unfair means of any kind is strictly prohibited; and, if indulged in, shall result in disqualification of the team.
- II. Intimidation in any form is prohibited; and, if indulged in, shall result in disqualification of the team.
- III. Teams are not allowed to carry any electronic gadget inside the court room.
- IV. Misconduct, whether behavioural or otherwise, is not allowed; and, if indulged in, shall result in disqualification of the team.

## **ARTICLE A3: Court Manners (Oral Arguments)**

- I. Failure to deliver an oral argument in entirety shall be considered a disqualification.
- II. It shall be the discretion of the organizing committee to decide on any violation of the provisions of the Rules and Regulations during the rounds and whether that violation entails penalty point.

III. If a participating team, member of the Bench or the timekeeper wishes to claim a violation, the Bench shall inform the organizing committee of the claim made and shall not consider it as a part of their deliberations unless directed to do so by the organizing committee.

## ARTICLE A4: Submission and Formatting of the Research Paper

I. Delay in the submission of the research paper, use of incorrect font or font size, use of font of inconsistent size, or improper line spacing, failure to include all parts of the research paper, or inclusion of an unenumerated part, substantive legal argument outside of approved sections of memorial, improperly formatted index of authorities, excessive length, failure to include necessary information on the memorial cover, inclusion of any identifying mark, character or text in the memorial shall result in imposition of penalties.

#### **ARTICLE A5: Dress Code**

- I. Strict adherence to the dress code is required. The teams are required to be in proper dress code.
- II. The participants are required to wear black trousers/skirts and white shirt, black blazers and black necktie.
- III. Failure to follow dress code shall result in imposition of penalty.

## ARTICLE A6: Non-Compliance with the Rules of OC

- The participants are required to comply with the rules formulated by the OC at all times during the Prof. N. R. Madhava Menon Global Jural Conclave.
- II. Total points collected by a team shall be reduced by the penalty points imposed for the violation of rules specified by the OC for each round in which the violation took place.
- III. One penalty point shall be imposed for each violation. One penalty point imposed shall reduce one mark from the score of the team. However, the total number of penalty points awarded against one team shall not surpass 10 points.

IV. If the penalty increases from ten (10) points, the team can be debarred from the competition. An opportunity of being heard by the OC can be offered to the team on request. The OC shall decide whether to debar that particular team from further participation in the competition or reduce the marks from the total score obtained by that team.
